SPAN is an initiative of civil society from countries badly affected by hard security responses to instability such as Afghanistan, Iraq, Nigeria, Chad, Libya, Mali, Nigeria, the Philippines, Somalia, Syria, and Yemen, and their colleagues working on security policy in Western policy centres such as Washington, New York, London, Brussels, Paris and Berlin.
